# City of Stanton

Council Members hold 4-year terms

- Districts 1 & 3 terms begin following election in November 2022
- Districts 2 & 4 terms begin following election in November 2024



# Redistricting Process

Step	Description
Initial Pre-Draft Hearings (2)	Held prior to release of draft maps. Education and to solicit input from the community Identify “neighborhoods,” “communities of interest,” and “secondary areas.”
Initial deadline for draft maps	Deadline for the public to submit draft maps for inclusion in the next hearing packet and presentation
Release draft maps	Draft maps posted to project website
Public Hearings (post-map) (2)	Public Hearings to discuss and revise or adopt the draft map(s)
Map adoption	Map adopted via ordinance or resolution. Final map must be posted at least 7 days prior to adoption. May happen at Hearing 4.

## California Criteria for Cities

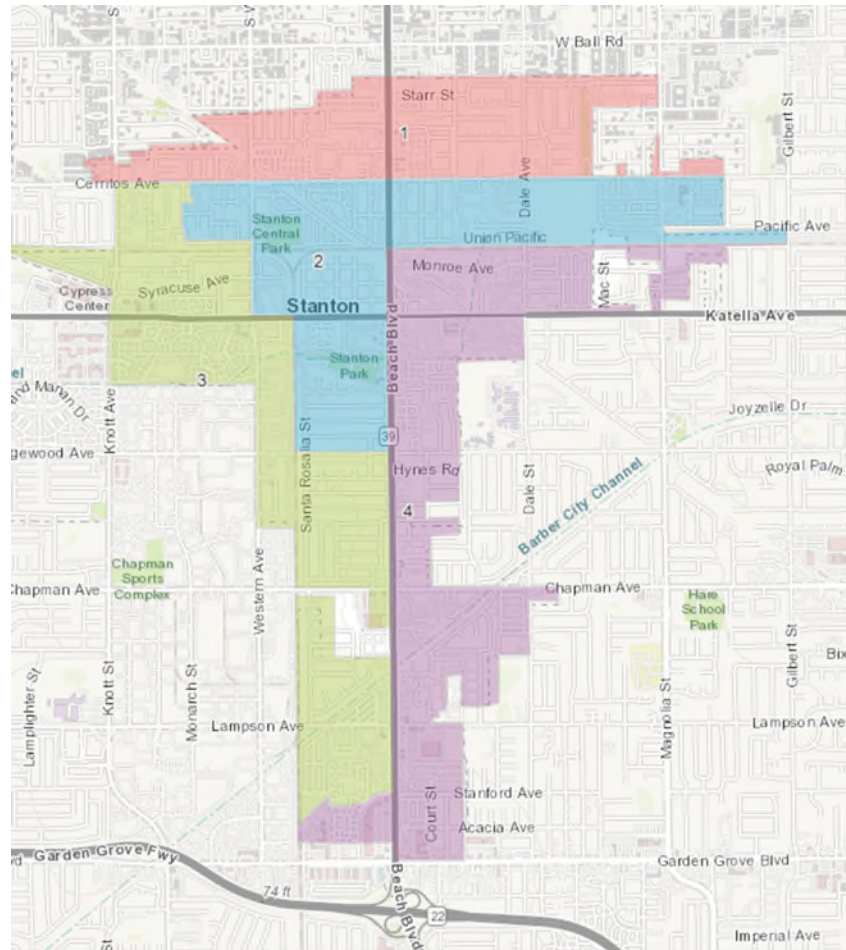
Geographically contiguous  
Geographic integrity of a local neighborhood, communities of interest  
Easily identifiable and understandable – use of local landmarks/boundary lines  
Geographically compact

## Other traditional principles

Minimize voters shifted to different election years  
Respect voters' choices / continuity in office  
Future population growth  
Preserving the core of existing districts

# Findings

- Total Deviation is higher than the “acceptable” range at 14.89%
- All four districts are already majority/minority population.
  - Districts 1, 2, & 4 are majority/minority Asian
  - District 3 is majority/minority Hispanic
- Current district boundaries **must** be adjusted for population balance





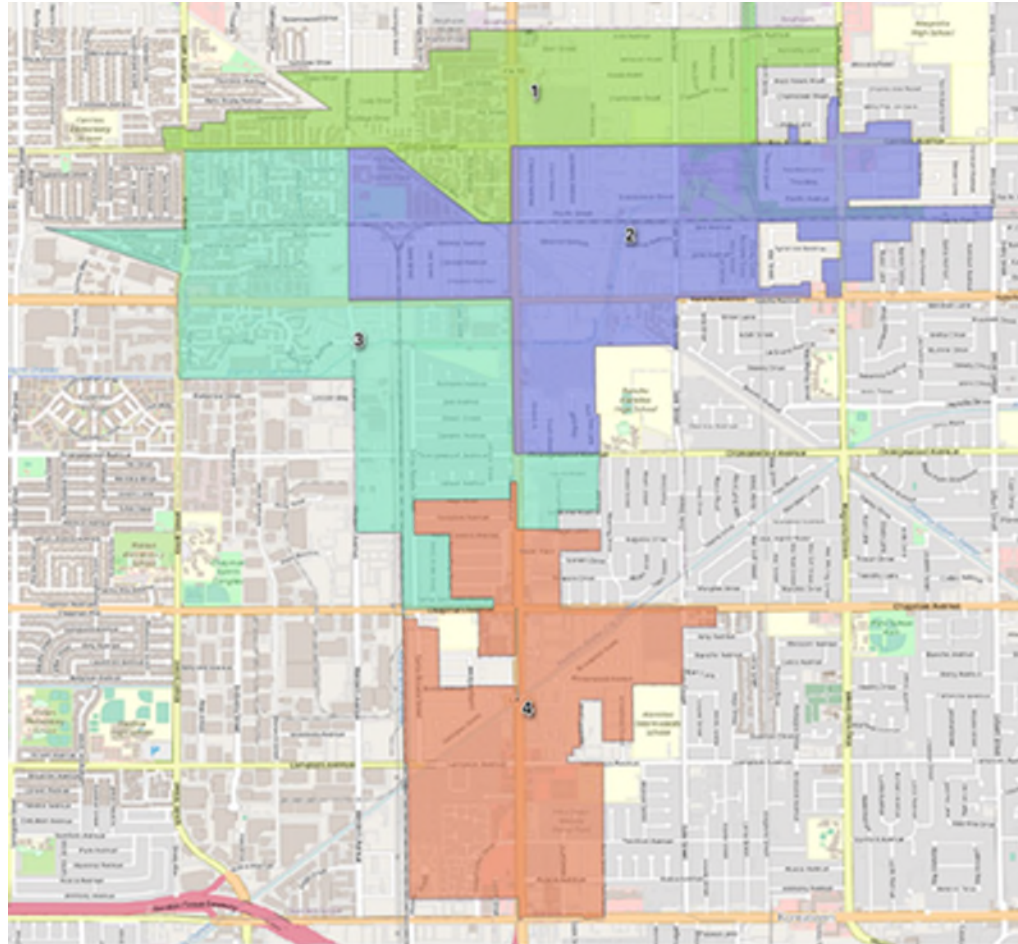

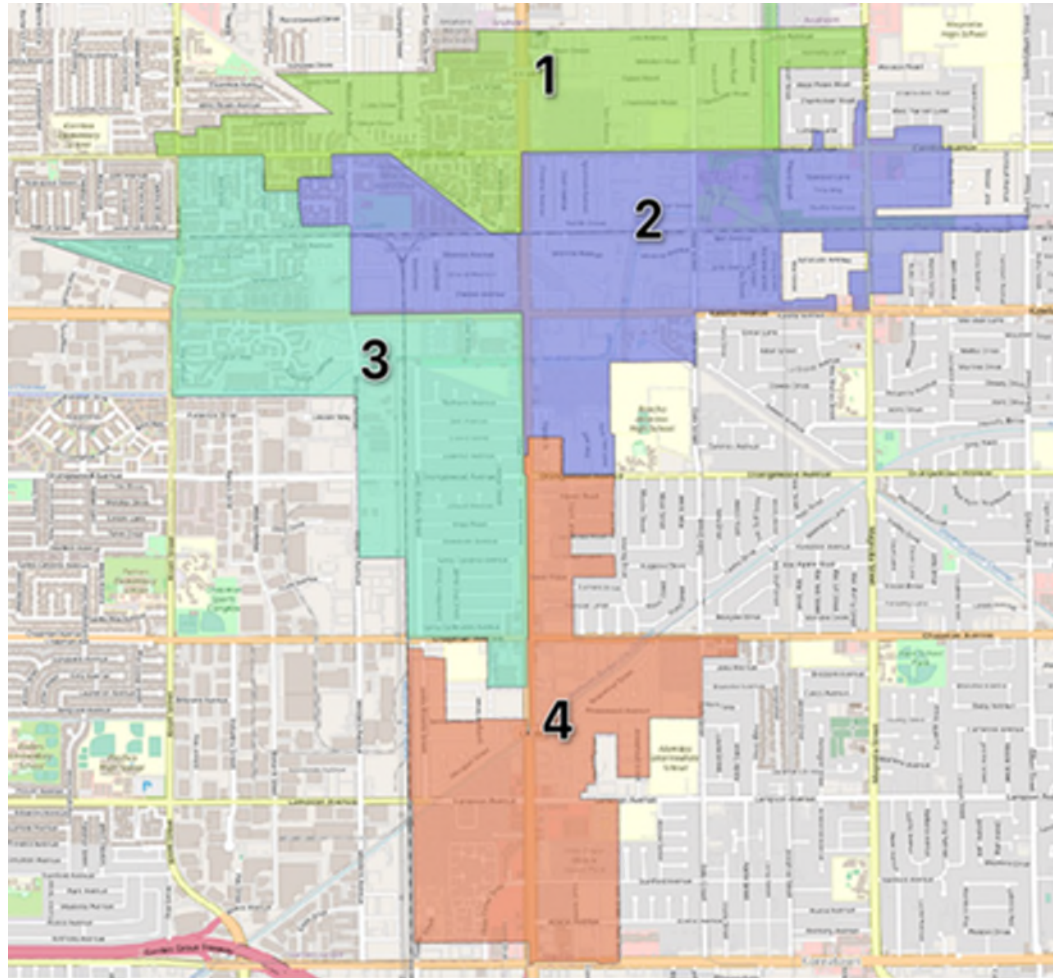


# Findings – Map Option A

- Deviation is 2.57%
- Preserves three majority/minority Asian voting districts and one majority/minority Hispanic voting district, although the Hispanic voting district shifts from District 3 to District 2.
  - Districts 1, 3, & 4 are majority/minority Asian
  - District 2 is majority/minority Hispanic
- Corrects the non-contiguous portions of Districts 1, 3, & 4
- Addressed Council's instructions regarding Crosspointe Village and the Stanton Family Resources Center

# Findings – Map Option B

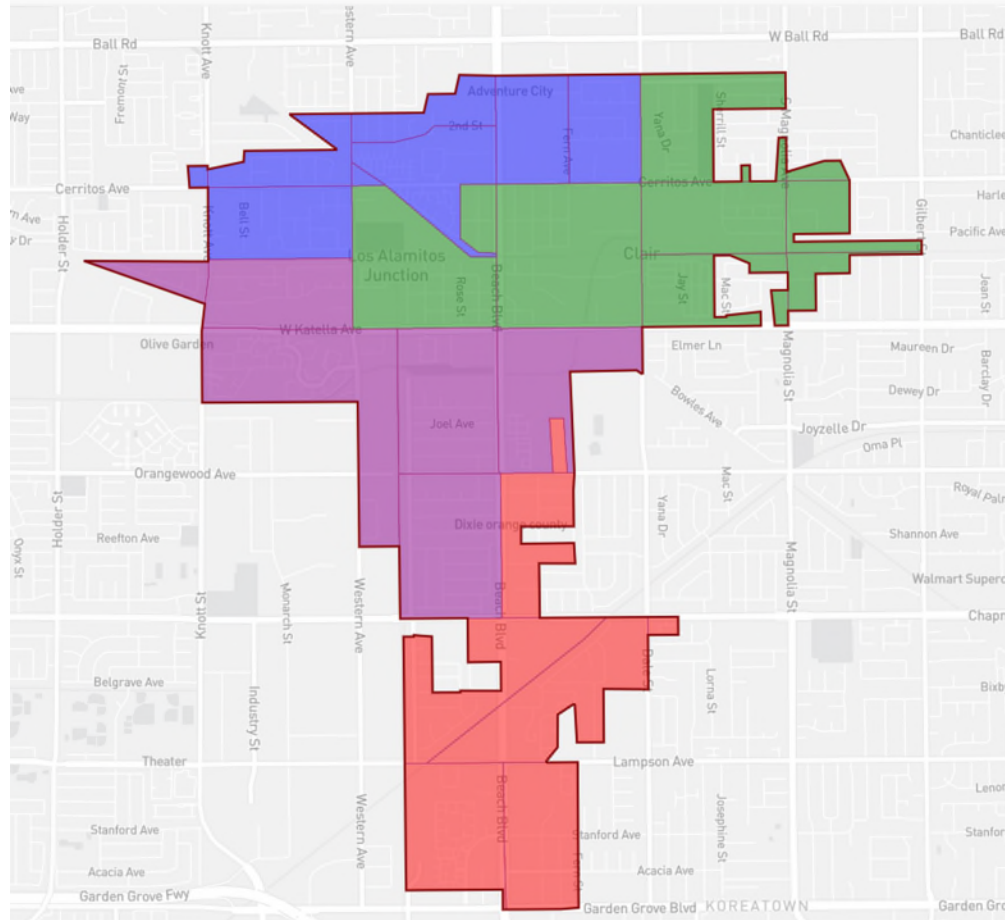
- Deviation is 5.75%
- Preserves three majority/minority Asian voting districts and one majority/minority Hispanic voting district, although the Hispanic voting district shifts from District 3 to District 2.
  - Districts 1, 3, & 4 are majority/minority Asian
  - District 2 is majority/minority Hispanic
- Corrects the non-contiguous portions of Districts 1, 3, & 4
- Addressed Council's instructions regarding Crosspointe Village and the Stanton Family Resources Center
- Resembles the current map with respect to District 4 east of Beach Boulevard

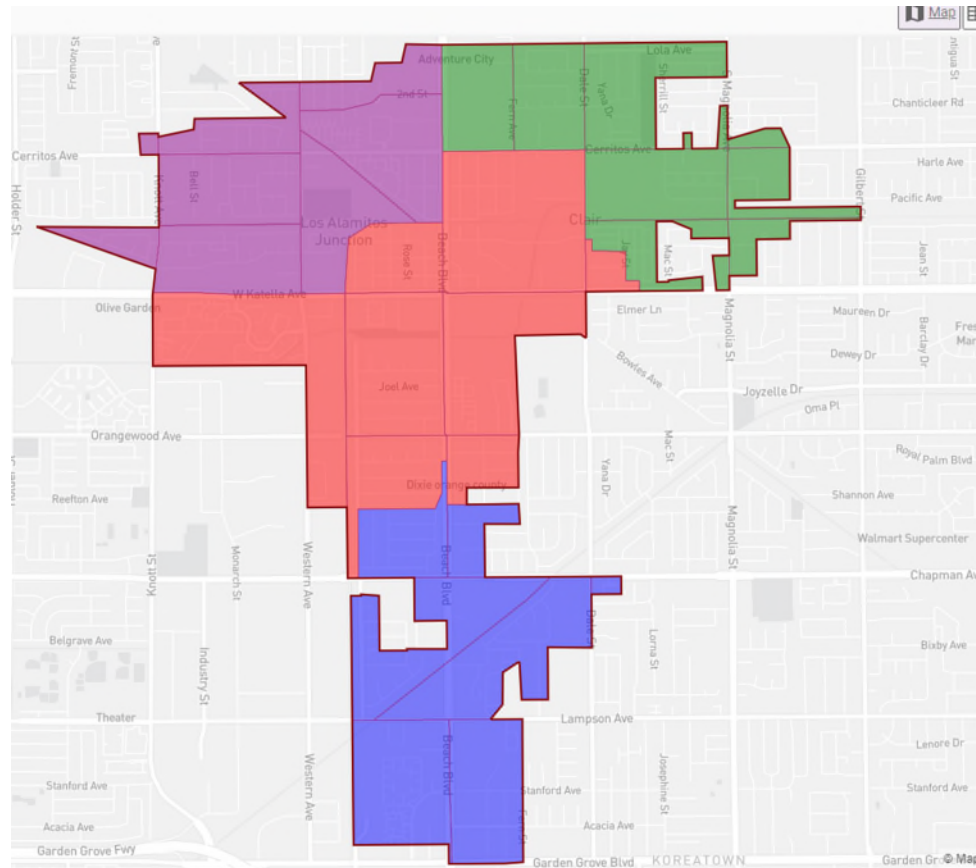


# Findings – Map Option C

- Deviation is 8.48%
- Preserves three majority/minority Asian voting districts and one majority/minority Hispanic voting district, although the Hispanic voting district shifts from District 3 to District 2.
  - Districts 1, 3, & 4 are majority/minority Asian
  - District 2 is majority/minority Hispanic
- Corrects the non-contiguous portions of Districts 1, 3, & 4
- Author was limited in the Jane Way/Pine Tree Way distribution, per notes submitted

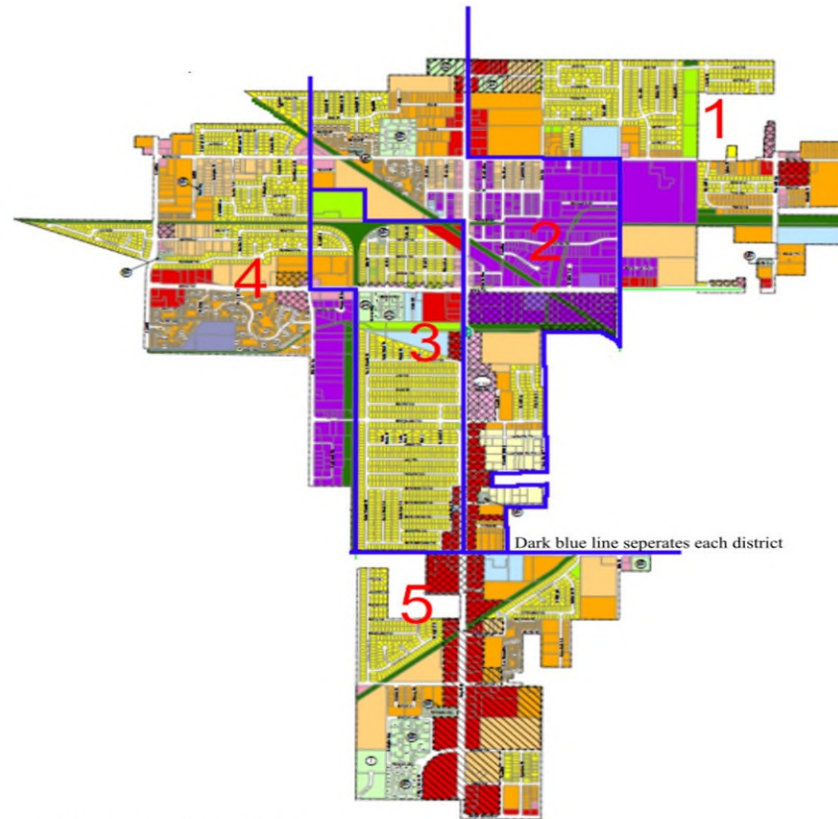

# Timeline & Next Steps

- Council to provide input on what changes they would like to see
- Revised maps, if necessary, will be drawn and presented at Public Hearing #4
- One additional public hearing must be held before the Council may vote on a proposed final boundary map.
- The approved map must be submitted to the County Registrar of Voters no later than April 17, 2022.

November 23, 2021	1 <sup>st</sup> public hearing Held prior to the release of draft maps
December 16, 2021	2 <sup>nd</sup> public hearing Held prior to the release of draft maps
December 20, 2021	Mapping tool released to the public
Winter 2021/22	BB&K to prepare draft maps using 2020 census data
January 10, 2022	Deadline for the public to submit draft maps for consideration at 3 <sup>rd</sup> public hearing
January 18, 2022	Publish draft map(s)
January 25, 2022	3 <sup>rd</sup> public hearing Consideration and input on proposed draft maps
February 22, 2022	4 <sup>th</sup> public hearing Council to introduce ordinance approving final maps.
April 17, 2022	City deadline to adopt ordinance after 2 <sup>nd</sup> reading (effective immediately) and to <b>submit map to Registrar.</b>
November 2022	2022 election
